COORDINATOR'S REPORT:

Kris Marple, County Coordinator, presented Resolution #2017-004 designating The Neodesha Derrick as the official County newspaper from April 1, 2017 to March 31, 2018. He also recommended to appoint Brad McVey to the Wilson County Zoning Board. He also submitted the monthly budget reports to the Commission.
