At 9:00 a.m. the County Commissioner & County Coordinator departed the Courthouse for a road viewing at 1450 & Ness Road at 9:30 a.m. There was no public comment, and they arrived back at the Courthouse at 9:50 a.m.

The Board of County Commissioners, three members, Rhonda Willard, County Clerk and Kris Marple, County Coordinator, met in regular session at 10:00 a.m. in the Commission room.

CALL TO ORDER: Commissioner Lair called the meeting to order.

INVOCATION: Commissioner Miller gave the invocation.

PLEDGE OF ALLEGIANCE: Commissioner Lair led the flag salute.

MINUTES:

ACTION: A motion was made by Commissioner Richardson to approve the agenda as presented, and approve the minutes of June 12, 2017 as presented. Commissioner Miller seconded the motion, and the motion carried.

ROAD & BRIDGE DEPT. REPORT:

Kary Tatum, Road & Bridge Supervisor discussed the plan for the new motor grader district. SHERIFF'S REPORT:

Sheriff Pete Figgins & Undersheriff Dana Moodie informed the Commissioners that they had received the insurance check in the amount of \$15,610.00 for the 2012 Chevy patrol truck that was totaled and will be purchasing a 2017 Chevy patrol truck for \$31,375.00 from the KHP Partners Program. They also inquired about the pay scale proposal for deputy sheriffs and corrections officers and the Commission informed them that the matter was still being discussed.

COORDINATOR'S REPORT:

Kris Marple, County Coordinator, presented the direct deposit agreement with The State Bank of Kansas for renewal. He also gave an update on the Thanks Program and further discussed the FY2018 budget preparation.

ACTION: A motion was made by Commissioner Miller to approve the renewal of the direct deposit agreement with The State Bank of Kansas. Commissioner Richardson seconded the motion, and the motion carried.
