September 26, 2016

At 1:00 p.m. the Board of County Commissioners, Kary Tatum, Road & Bridge Supervisor, and Kris Marple, County Coordinator met at 800 & Barber Road to have a hearing on a request to place another stop sign at the intersection. Also present were: Dee Tindle, Marvin Taylor & Bob Smith. Commissioner Lair opened the hearing for public comments with Marvin Taylor the only one in favor of the request. Following discussion, Commissioner Lair closed the hearing at 1:08 p.m.

The Board of County Commissioners, three members, Rhonda Willard, County Clerk, and Kris Marple, County Coordinator, met in regular session at 2:00 p.m. in the Commission room.

MINUTES:

ROAD & BRIDGE REPORT:
