## **ROAD & BRIDGE DEPT. REPORT:**

Kary Tatum, Road & Bridge Supervisor, discussed the status of the low-water bridge work at 275 & Rooks Rd. He also informed that the noxious weed truck was in operation. He also discussed a request that Harper Road be striped with yellow center lines, but stated that the material & engineering costs for a center line would be cost prohibitive, however in the future there may be funds available to strip the white lines. He also presented pay increase requests for Arnold Thomas & Billy Scheer.

**ACTION:** A motion was made by Commissioner Richardson to approve a \$0.50 per hour pay increase for Arnold Thomas due to not receiving it at the end of his introductory period and a \$0.50 per hour pay increase for Billy Scheer due to changing positions from a truck driver to motor grader operator. Commissioner Miller seconded the motion, and the motion carried.

**ACTION:** A motion was made by Commissioner Miller to purchase the new security cameras and server from Sandifer Engineering & Controls in the amount of \$36,221.00. Commissioner Richardson seconded the motion, and the motion carried.

### **COORDINATOR'S REPORT:**

Kris Marple, County Coordinator, discussed the status of the Neighborhood Revitalization Program with the Commission. He also submitted a proposal from Fridge Freeze for a new portable freezer for the Health Department's immunization clinic vaccine in the amount of \$4,810.00. He also submitted a proposal from A-1 Electric for a new air conditioner in the Electronics Room at the LEC in the amount of \$3,780.00. He also presented the FY2018 proposed County budget summary for publication with a 1.7 mill increase, and does not exceed the amount of taxes levied in FY2017. The Budget Hearing is scheduled for August 21<sup>st</sup> at 4:00 p.m.

**ACTION:** A motion was made by Commissioner Miller to approve the quotes from Fridge Freeze & A-1 Electric as presented. Commissioner Richardson seconded the motion, and the motion carried.

**ACTION:** A motion was made by Commissioner Miller to approve the FY2018 proposed County budget summary for publication. Commissioner Richardson seconded the motion, and the motion carried.
