## **ZONING CASE #SU-2021-002 & RESOLUTION #2021-004:**

At 10:15 a.m. Commissioner Lair opened public comment for a Special Use Permit request from Monarch Cement Company to establish a sandstone excavation pit located South of 1700 Road, between Barber Road & Clay Road. Kris Marple, Zoning Administrator, reported on the Zoning Hearing and that the permit request was favorably recommended unanimously by the County Zoning Board. No petitions were received during the 14-day protest period. Kenny Miller & Brent Wilkerson with the Monarch Cement Company discussed their application, and answered questions. Evan Dunn & Evan Ratzlaff with Dunn's Trucking & Material, and J.C. Bickford were also present. The public comment period closed at 10:25 a.m.

**ACTION:** A motion was made by Commissioner Scott to adopt Resolution #2021-004 approving the Special Use Permit with conditions. Commissioner Lair seconded the motion, and the motion carried. Commissioner Miller abstained due to owning property within 1000 feet from the subject property owned by Monarch Cement Company.
