February 5, 2020

The Board of County Commissioners, three members, and Kris Marple, County Coordinator, met in regular session at 9:00 a.m. in the Commission Room. Rhonda Willard, County Clerk, was absent.

CALL TO ORDER: Commissioner Lair called the meeting to order.

INVOCATION: Commissioner Miller gave the invocation.

PLEDGE OF ALLEGIANCE: Commissioner Lair led the flag salute.

AGENDA & MINUTES:

ACTION: A motion was made by Commissioner Scott to approve the agenda as presented, and approve the minutes of January 29, 2020 as presented. Commissioner Miller seconded the motion, and the motion carried.

ROAD & BRIDGE REPORT:

Kary Tatum, Road & Bridge Supervisor, discussed equipment in need of replacement. He presented a 1992 Kenworth W900 semi-truck for sale in the amount of \$15,000.00.

Kevin Starbuck discussed his costs for crushing road rock at \$7.00-\$7.50 per ton. He also informed that if the County leased or purchased a quarry site, then his cost would be estimated at \$6.00 per ton.

KDOT UPDATE:

Wayne Gudmonson, District 4 Engineer, Darrin Petrowsky, Area 3 Engineer & Kristy Kelley, District 4 Community Affairs Manager, gave an update on KDOT including the Cost Share program renewal, and the proposed Forward Kansas 10-year Transportation program being discussed by the Governor & Legislature.

COORDINATOR REPORT:

Kris Marple, County Coordinator, presented a letter of support for an increase of financial aid to Local Health Departments from KDHE for signature.

ACTION: A motion was made by Commissioner Miller to approve the letter of support as presented. Commissioner Scott seconded the motion, and the motion carried.
