

**WILSON COUNTY, KANSAS
OFFICIAL MINUTES**

January 12, 2022

The Board of County Commissioners, Casey Lair, Andrew Miller & Jerry Scott, and Kris Marple, County Coordinator, met in regular session at 9:00 a.m. in the Commission Room.

CALL TO ORDER: Commissioner Lair called the meeting to order.

INVOCATION: Commissioner Miller gave the invocation.

PLEDGE OF ALLEGIANCE: Commissioner Scott led the flag salute.

AGENDA & MINUTES:

ACTION: A motion was made by Commissioner Scott to approve the agenda as presented, and approve the minutes of January 5, 2022 as presented. Commissioner Miller seconded the motion, and the motion carried.

ROAD & BRIDGE DEPT. REPORT:

Kary Tatum, Road & Bridge Supervisor, reported on truck repairs, ditching on 1650 Road between Inman Road & Jade Road, clearing brush at 10 Road & Lane Road, and culvert repairs at 10 Road & Marion Road. He also presented a right-of-way permit for Montgomery County RWD #12 for boring a water-line.

ACTION: A motion was made by Commissioner Scott to approve the ROW permit as presented. Commissioner Miller seconded the motion, and the motion carried.

COORDINATOR'S REPORT:

Kris Marple, County Coordinator, presented Neighborhood Revitalization Plan applications for Dee Ann Voth-Ogden, George Hanson, and Douglas Thum. He also submitted monthly budget reports, and January employee birthday cards for signature.

ACTION: A motion was made by Commissioner Miller to approve the NRP applications as presented. Commissioner Scott seconded the motion, and the motion carried.

OTHER BUSINESS:

1. Charles James & Roy Tomlinson complained about truck traffic, the dangerous entrance of Midwest Mineral quarry, and no traffic patrol on 300 Road.
2. Sheriff Jack Lucke reported that due to the increase in truck prices, he has postponed the purchase of new patrol vehicles until later this year.
3. Eric Vogel & John Terry, Kwikom Communications, gave an update on equipment upgrades, and apologized for the recent Internet outages due to equipment repairs.
4. Approved payroll in the amount of \$118,107.65 & warrants in the amount of \$105,355.85.
5. Approved tax roll corrections: 2022-005, 007, 021, 090 & 091.
6. Reports received: Health Dept fee reports, and Employee Overtime report.
