## **ROAD & BRIDGE DEPT. REPORT:**

Kary Tatum, Road & Bridge Supervisor, informed that 1700 & Decatur Roads were reopened, but a portion of Coyville Road is temporarily closed due to a bridge partially collapsed. He also discussed drainage issues on 800 & Finney Roads due to fields draining into the County ditch. The Commission further discussed options of how to enforce permitting regulations to avoid further problems. Kary also reported that motor grader operators & truck drivers are working on Fridays due to the recent flooding.

Sam Reed presented pictures of the culvert washed out on 1925 Road, West of Decatur Road. He discussed the damage to the road and his fence, and requested to add rock to the ditch to prevent further erosion or to put it back as a low water crossing.
