Destany Wheeler, Health Dept. Administrator, reported that the Health Dept will begin flu vaccinations on Oct. 1st and the drive-thru flu shot clinic will be on Oct. 5th. She also discussed issues with Vaxcare, their vaccine billing vendor, and requested to stop using them in 2019.

SHERIFF'S DEPT. REPORT:

Sheriff Pete Figgins & Undersheriff Dana Moodie, discussed purchasing a new inmate transport van to be paid from the inmate commissary fees fund. They also reported that they are submitting a grant application to Enbridge Pipeline again this year.

COORDINATOR'S REPORT:

Kris Marple, County Coordinator, presented a quote for a new 911 dispatch radio in the amount of \$4,833.66. He also submitted a \$0.50 per hour pay increase request for Walter McClure due to completing his introductory period. He also gave a tax sale update to the Commission.

ACTION: A motion was made by Commissioner Miller to approve the pay increase for Walter McClure as presented. Commissioner Lair seconded the motion, and the motion carried.
