#### **FY2020 EMS BUDGET REQUEST:**

Duane Banzet, Neodesha EMS Director, Todd Ballard, Fredonia EMS Director, John Durrett, FRH CEO, and Ed Truelove, Neodesha City Administrator presented County-wide EMS statistical information showing revenue deficits compared to the County Ambulance Funds allocated, and requested an increase in tax revenue. They also discussed the options of a ½ cent sales tax dedicated to EMS services.

## **NEODESHA SALES TAX SPECIAL QUESTION CANVASS OF VOTES:**

The Commission convened as the Board of Canvassers to canvass the votes of the Neodesha Sales Tax Special Question. There were 11 eligible provisional ballots, of which 5 were counted making the official results 192 no to 103 yes.

Kris Marple, County Coordinator, presented Resolution #2019-010 declaring a State of Local Disaster Emergency for Wilson County due to the flash flooding on June 23, 2019. He also presented Resolution #2019-011 adopting the Kansas Homeland Security Region H Hazard Mitigation Plan. He also submitted a Certificate of Merit for Nadine Dishman for her 30+ years of service at the Wilson County Historical Society for signature. He also discussed removing a property from the tax sale proceedings for the Neodesha Land Bank, which was approved by consensus as long as the transactions were completed & fees paid by the redemption date.

**ACTION:** A motion was made by Commissioner Miller to approve Resolutions #2019-010 & #2019-011 as presented. Commissioner Scott seconded the motion, and the motion carried.
