

**WILSON COUNTY, KANSAS
OFFICIAL MINUTES**

March 20, 2019

The Board of County Commissioners, three members, Rhonda Willard, County Clerk, and Kris Marple, County Coordinator, met in regular session at 9:00 a.m. in the Commission Room.

CALL TO ORDER: Commissioner Lair called the meeting to order.

INVOCATION: Commissioner Miller gave the invocation.

PLEDGE OF ALLEGIANCE: Commissioner Lair led the flag salute.

AGENDA & MINUTES:

ACTION: A motion was made by Commissioner Scott to approve the agenda as amended, and approve the minutes of March 13, 2019 as presented. Commissioner Miller seconded the motion, and the motion carried.

ROAD & BRIDGE DEPT. REPORT:

Kary Tatum, Road & Bridge Supervisor, discussed drainage on Cement Plant Road. He also proposed changing the Road & Bridge employees work schedules to 10 hours per day, 4 days per week beginning on May 6th, which was approved by consensus. He also presented bridge engineering estimates from CFS Engineers in the amount of \$32,000.00.

Travis Clinesmith with Murphy Tractor Company, submitted a quote for a used 2017 John Deere tractor & Diamond boom mower in the amount of \$127,500.00.

Leland Shire met with the Commission again about concerns with the intersection at 500 & Decatur Road. He also expressed his disagreements with how the roads are being rocked & graded.

ACTION: A motion was made by Commissioner Miller to approve the bridge estimates from CFS Engineers as presented. Commissioner Scott seconded the motion, and the motion carried.

ACTION: A motion was made by Commissioner Miller to purchase the 2017 John Deere tractor & Diamond boom mower as presented. Commissioner Scott seconded the motion, and the motion carried.

2018 NOXIOUS WEED ANNUAL PROGRESS REPORT:

Steve Finley, Noxious Weed Director, presented the 2018 Noxious Weed Eradication Progress Report for review & approval.

ACTION: A motion was made by Commissioner Miller to approve the report as presented. Commissioner Scott seconded the motion, and the motion carried.

HEALTH DEPT. REPORT:

Destany Wheeler, Health Dept. Administrator, requested that Atlantic Health Partners be their new vaccine purchasing group. She also reported that employment applications are being received for the office manager position. She also presented the 2019 State of Kansas Health Rankings, which Wilson County increased to 94th from 98th. She also informed that the Community Health Improvement Plan committee received 1500 surveys for their development of a new Community Health Assessment.

ACTION: A motion was made by Commissioner Scott to approve Atlantic Health Partners as the new vaccine purchasing group for the Health Dept. Commissioner Miller seconded the motion, and the motion carried.

COORDINATOR REPORT:

Kris Marple, County Coordinator, submitted the monthly budget reports, and the March employee birthday cards for signature.
