

**WILSON COUNTY, KANSAS
OFFICIAL MINUTES**

June 10, 2020

The Board of County Commissioners, three members, and Kris Marple, County Coordinator, met in regular session at 9:00 a.m. in the Commission Room. Rhonda Willard, County Clerk, was absent.

CALL TO ORDER: Commissioner Lair called the meeting to order.

INVOCATION: Commissioner Miller gave the invocation.

PLEDGE OF ALLEGIANCE: Commissioner Lair led the flag salute.

AGENDA & MINUTES:

ACTION: A motion was made by Commissioner Scott to approve the agenda as presented, and the minutes of June 3, 2020 as presented. Commissioner Miller seconded the motion, and the motion carried.

ROAD & BRIDGE DEPT. REPORT:

Kary Tatum, Road & Bridge Supervisor, discussed issues with the Bobcat and the Commission agreed to sell it and pursue a different one. He also informed that the department is changing to 4-10 hour days per week, except the motor grader operators. He also reported on ditch work at 2400 & Decatur Road, 700 & Scott Road, bridge repairs at 700 & Decatur Road, and replacing the culvert bridge at 1925 & Decatur Road. He also submitted a \$0.50 per hour pay increase for Benny Culbertson due to completing his introductory period.

Bob Smith expressed his appreciation for the road work & rock that he requested last week.

ACTION: A motion was made by Commissioner Miller to approve the pay increase for Benny Culbertson as presented. Commissioner Scott seconded the motion, and the motion carried.

COORDINATOR'S REPORT:

Kris Marple, County Coordinator, presented quotes for a Lanier copier/printer from Digital Connections to replace the shared copier at the Courthouse in the amount of \$4,995.00. He also submitted an employee application from Jesse Linnebur for 911 Dispatcher, which was approved to hire by consensus. He also presented Certificates of Merit for Jack Lucke & Veda Roets for signature. He also discussed a request to use the Courthouse parking lot for a Business Bash on June 16th from 5pm to 8pm, which was agreed to by consensus. He also submitted the monthly budget reports.

ACTION: A motion was made by Commissioner Scott to approve the purchase of a Lanier copier/printer in the amount of \$4,995.00 as presented. Commissioner Miller seconded the motion, and the motion carried.

OTHER BUSINESS:

1. Approved warrants in the amount of \$225,342.22.
2. Reports received: Road & Bridge fee report, and 911 calls log.
